## Rules and Regulations

### The Contest

The Contest is sponsored by Kawartha Credit Union, 14 Hunter Street East, PO Box 116, Peterborough, Ontario K9J 6Y5. The Contest start date is September 15 at 9:00 a.m. Eastern Standard Time and the Contest ends on September 27 at 3:00 p.m. Eastern Standard Time. All entries must be received within the Contest Period in order to be eligible to win.

### Eligibility

The Contest is open to residents of Ontario who are 18 years of age or older on the date of contest entry. Employees, directors, contractors, agents or representatives of Kawartha Credit Union, or its affiliates, agencies, distribution companies, third party vendors, or any person who is a member of the immediate families of such employees or representatives are not eligible to win. For the purpose of this contest, "immediate family" is defined as parent, sibling, child or any person residing in the same household as any such employees or representatives.

### How to Enter

To participate in the Contest, participants must register (via the Zoom links provided by Kawartha Credit Union) between 9:00 a.m. on September 15 to 3:00 p.m. on September 27 for one of the two Aviso RESP webinars.

### Prize

The prize is one (1) \$250 contribution to an RESP at Kawartha Credit Union. The RESP must be opened by the winner at Kawartha Credit Union before December 31, 2022.

### Determination of Winner

There will be 1 ballot for each webinar registration. Each participant can enter the draw only once.

A random draw will be conducted on October 1, 2022 by the Contest judges at 14 Hunter Street East, Peterborough, Ontario. The prize will be paid out within 30 days of the RESP account being opened at Kawartha Credit Union. .

### Winner Notification

The winner will be verified and then contacted by a Kawartha Credit Union representative by telephone. Any selected entrant who cannot be contacted (or who fails to respond to any telephone message left for such selected entrant) within seven (7) days of Kawartha Credit Union's first attempt to contact such selected entrant may, at the sole discretion of Kawartha Credit Union, be declared disqualified (ineligible to win) and the contest judges reserve the right, in such event, to select at random one or more additional entrants whom they shall attempt to contact, and who shall be subject to disqualification, in the same manner.
